Contraindications

Orthopaedic Conditions

- Acute herniated intervertebral disk
- Atlanto-axial instability, will be allowed to participate with physician confirmation that a current xray indicates stability
- Any acute injuries
- Arthritis: acute or inflammatory stage
- Brittle bones (osteogenesis imperfecta) or other pathological fractures
- Coxarthrosis
- Complete quadriplegia
- Dislocation, subluxation or dysplasia of the hip(s)
- Heterotropic ossification in the hip
- Joint replacement
- Moderate to Severe Osteoporosis
- Spinal instability
- Spondylolisthesis
- Structural scoliosis greater than 30 degrees, excessive kyphosis, lordosis, hemivertebra

Medical Conditions

- Any injury, illness or disease in an acute phase, or recent surgery
- Aneurysm, Angioma
- Blood thinner medication used by rider
- Hemophilia
- Hydrocephalus, cranial deficits, shunt; which a helmet will not fit over
- Narcolepsy
- Serious heart condition
- Substance abuse and related disorders
- Uncontrolled Seizures within the last 6 months
- Unstable Diabetes
- Use of medications with affect alertness

Mental Health Conditions

Patients/Clients experiencing the mental health challenges listed below, who are not currently stabilized on a treatment program, or those whom you consider may be dangerous to themselves, others or animals. Please note that <u>we offer therapeutic programming</u>, not therapy.

- Bipolar
- Disruptive disorders
- Dissociative disorders
- Significant neurocognitive disorders
- Schizophrenia/Psychosis

Possible Contraindications:

- Arnold Chiari malformation
- Body sores or skin breakdown in the seat/leg areas
- Incontinence
- Prolonged use of Dilantin
- Rhizotomy in the last 6 months
- Sensory deficit/lack of feeling in specific body parts
- Significant Allergies or Asthma triggered by dander, dust, horse hair, mold etc.
- Spinal fusion/Harrington rod
- Tethered cord
- Any other medical or mental health concern you may have
